

Introduction to Kumamoto City’s business location subsidy system

Kumamoto City offers **one of the best subsidy systems in the country**. **Up to 8 billion yen**
(In combination with subsidies from Kumamoto Prefecture)

Subsidy system under the Kumamoto City Business Location Promotion Ordinance

Support for the cost of land acquisition, and employment related to establishing a business office in Kumamoto City

Support for manufacturing and logistics-related industries

Up to 3 billion yen

- Target industries: manufacturing, road freight transport, packaging, warehousing
- Target facilities: factories, logistics centers, research and development facilities
- Subsidy details: **Land acquisition subsidy**
15 % of land acquisition cost, **1/2** of rent (land and building) for **12** months
Equipment investment subsidy
7-10 % of the acquisition cost of invested fixed assets (buildings and depreciable assets)
Employment promotion subsidy
Up to **1** million yen per newly hired full-time employee

Kumamoto City Marketing Research Promotion Subsidy

Support for necessary expenses for site visits to consider locating in Kumamoto City

Approximately half Price subsidy

- Eligibility Requirements: Companies with headquarters located in one of the three major metropolitan areas.
Greater Tokyo Area:Tokyo,Kanagawa,Saitama,Chiba
Chubu region:Aichi,Shizuoka
Kansai region:Osaka,Kyoto,Hyogo
- Target companies and industries: Manufacturing, transportation, software, internet-related service, information processing and provision services, content businesses, companies considering relocating their headquarters, etc
- Subsidy amount: For those coming from the Tokyo metropolitan area 35,000yen per person
If you are coming from the Chubu or Kansai region 25,000yen per person
Subsidies are available for up to two people per company.

Following the expansion of TSMC, the largest semiconductor contract manufacturer, into Kumamoto Prefecture, the city has been working with private developers to develop industrial sites for concentration of semiconductor-related industries.

- Target Areas In principle, semiconductor-related industries (A). * (B) is also acceptable, provided it does not exceed half of the total area.

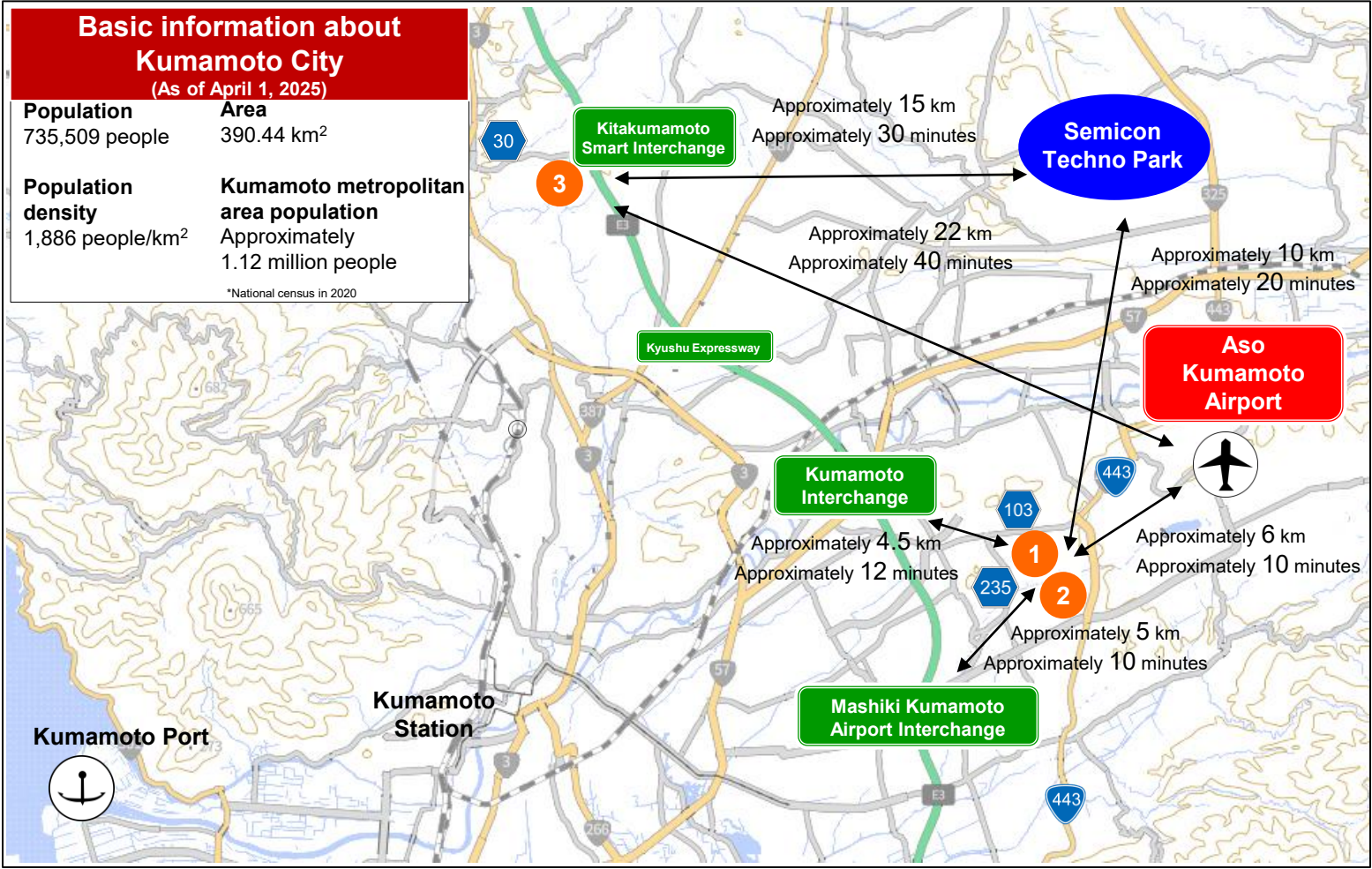
Semiconductor-related industries (A)

- The manufacture, design, and research and development of related parts and materials for semiconductors and semiconductor manufacturing and testing equipment
- The manufacture and research and development of products equipped with semiconductors
- Distribution of semiconductors

Sector (B) as stipulated in the regional features and their utilization strategies of the Kumamoto Prefecture Regional Future Investment Promotion Act Basic Plan

- Profitable agriculture, forestry and fisheries sector utilizing local specialties of Kumamoto prefecture such as "Kumamoto no Aka"
- An industrial sector that coexists with nature (agriculture, biotechnology, and healthcare sectors) by utilizing the natural environment of Kumamoto prefecture, such as the mountains of the Aso region and the sea of the Amakusa region
- Growing the manufacturing sector by utilizing Kumamoto prefecture's industrial clusters in semiconductors, transportation machinery, food, pharmaceuticals, and medical equipment
- An information and communications-related sector utilizing Kumamoto prefecture's industrial clusters such as BPO centers and call centers
- A tourism and sports sector utilizing tourism resources such as Aso-Kujū National Park in Kumamoto prefecture
- The Fourth Industrial Revolution sector in Kumamoto prefecture, utilizing the know-how of the Kumamoto Prefectural Industrial Technology Center and the Kumamoto Prefectural IoT Promotion Lab
- A sector in Kumamoto prefecture related to business continuity planning (BCP) measures utilizing lessons learned from the Kumamoto earthquake
- An urban development sector utilizing transportation infrastructure such as Kumamoto Airport, Yatsushiro Port, Kumamoto Port, and Kumamoto Station in Kumamoto prefecture

It takes about 8 minutes to get to the interchange, and there is no congestion with two lanes in each direction. It is also close to the city center, which is located approximately 10 km away in a straight line.
